## **Executive Session Attendance**

## **Instructions for Media Application**

Pursuant to ORS 192.660(4), representatives of the news media shall be allowed to attend executive sessions other than those held pursuant to ORS 192.660(2)(d) (labor negotiations) or ORS 192.660(2)(h) (litigation – when the member of the news media is a party to the litigation or is an employee, agent, or contractor of a news media organization that is a party to the litigation). [ORS 192.660(5)]. When the media attends an executive session, the City Council requires that information discussed in executive session not be disclosed.

The City Council for the City of Lincoln City is tasked with the responsibility of determining who is a representative of the news media for purposes of attending an executive session meeting. Any interested applicant must complete the Application for Recognition as a Representative of News Media form and submit it and any supporting documents to the Lincoln City Recorder. Only applications submitted on the prescribed form will be considered. Upon receipt of a completed application form and any supporting information, consideration of the application will be placed on the agenda for the Lincoln City Council's next regularly scheduled public session meeting. When a complete application for recognition as news media is pending, the City Council will delay any scheduled executive session meeting until a decision on the application is made by Council.

For guidance as the type of evidence that would be helpful to the City Council's determination, applicants are encouraged to review the April 18, 2016 Oregon Attorney General Opinion, a copy of which is attached.
