# **Mobi-mat Panel**

Panel 6.5 feet wide and 2.1 feet long.

Panel will be added to an existing Mobi-mat located at NW 40<sup>th</sup> St., NW 34<sup>th</sup> St. Grace Hammond, D River Wayside, SW 51st St. (locations may vary)

Mobi-mats are eco-friendly made from 100% recycled polyester, resistant to UV and salt water-resistant.

Mats are placed on the beach from Memorial Day to Labor Day.

LCP&R must approve the final wording to align with our mission and values.

### **Process for Review**

LCP&R must approve the final wording to align with our mission and values. Review of commemorative items application is by the Parks & Recreation Director.

### **Plaques and Mobi-mat Panels**

Donors are responsible for any repair or replacement costs of the plaque or Mobi-mat panel. The plaque or Mobi-mat will be installed by LCP&R. Plaques are bronze and include 3" brass all-thread lugs with brass nuts. Plaques are no larger than 3" x 9". The Mobi-mat panels are 6.5 feet wide and 2.1 feet long and made from recycled polyester. Message should be very simple statement recalling the event or person memorialized, and will include no birth or death dates. LCP&R must approve final wording before the order is submitted.

# <u>Installation of the Commemorative Item</u>

The commemorative item will be ordered once payment is received. When the item has been received and installation scheduled, the donor will be informed of the estimated installation date. This can take several weeks after the receipt of the payment. Installation will be coordinated with donor's schedule whenever possible.
