1 2 **RESOLUTION NO. 2021-04** 3 A RESOLUTION OF THE CITY OF LINCOLN CITY, 4 5 CALLING FOR A SPECIAL ELECTION TO FILL THE VACANT MAYOR POSITION ON THE CITY COUNCIL FOR THE CITY OF LINCOLN CITY 6 7 8 **RECITALS** 9 WHEREAS, on December 14, 2020 Dick Anderson resigned his City Council position 10 as Mayor of Lincoln City during the regular meeting; Council accepted his resignation; 11 and 12 13 **WHEREAS**, Chapter VIII, Section 8.2, of the Lincoln City Charter, provides: 14 15 8.2 Filling Vacancies 16 17 A vacancy in the council shall be filled by appointment by majority of the 18 council, provided, however, that the council may in its discretion call a special 19 election for the purpose of filling such vacancy. The appointee's term shall 20 21 begin immediately upon his or her appointment and qualification and shall continue through the unexpired term of the appointee's predecessor. During 22 the temporary disability of a council member, or during a member's absence 23 from the city, the office may be filled pro-tem in the manner provided for 24 25 filling vacancies in office. 26 WHEREAS, at a special meeting of the City Council on December 21, 2020, pursuant 27 Chapter VIII, Section, 8.2, of the Lincoln City Charter, the City Council deliberated on 28 29 the question of whether to appoint a qualified elector to fill the vacancy or refer such vacancy to a Special Election to be held in May 2021; and 30 31 WHEREAS, after due deliberation Council elected to call for a special election in May 32 33 2021 to fill the vacancy; and 34 35 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF **LINCOLN CITY, AS FOLLOWS:** 36 37 SECTION 1. The above recitals set forth above are true and correct and are 38 incorporated herein by this reference. 39

SECTION 2. The City Council hereby declares a vacancy to exist on the City Council, specifically, the position of Mayor, owing to the December 14, 2020 resignation of Mayor Dick Anderson; and **SECTION 3.** The City Council hereby calls for a special election to fill the vacancy on the city council position of Mayor, and directs the City Recorder to notify the County Elections Officer and provide notice as set forth in Lincoln City Municipal Code, Chapter 1.12 of the applicable deadline for candidate filing for the May 2021 election. **SECTION 4.** This resolution is effective as of the date of its adoption and signature by the Council President.
