**A RESOLUTION OF THE CITY OF LINCOLN CITY,
ADOPTING FEES AND CHARGES FOR CHAPTER 15.16 (FLOOD DAMAGE
PREVENTION) ACTIONS, ESTABLISHING APPEAL FEES AND VARIANCE
APPLICATION FEES AND CHARGES**

WHEREAS, the City of Lincoln City has established fees and charges for various applications and license applications; and

WHEREAS, the City has recently clarified appeal and variance processes in Chapter 15.16 with application and appeal fees to be established by Resolution; and

WHEREAS, ORS 294.160 mandates that the City provide an opportunity for public comment when fees or charges are established or increased; and

WHEREAS, on January 25, 2021, the City Council provided an opportunity for public comment on the proposed new fees and charges proposed by Resolution; and

WHEREAS, Council desires to establish new fees and charges and/or increase fees and charges as set forth herein; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LINCOLN CITY, AS FOLLOWS:

Section 1. The recitals set forth above are true and correct and incorporated herein by this reference.

Section 2. The fee for appeal under LCMC Chapter 15.16 shall be \$150.00. The fee for application variance shall be \$750.00 plus \$41.00 per hour for greater than 10 hours.

Section 3. The attached Exhibit A schedule of fees and charges are hereby adopted as the current fees and charges for the listed appeal and variance applications, and are incorporated herein by this reference.

Section 4. The above referenced fees and charges will be incorporated into the omnibus fee resolution to be adopted later this year.

Section 5. This Resolution is effective as of the date of its adoption.


