27	Section 2. The attached Exhibit A schedule of fees and charges are hereby
28	adopted as the current fees and charges for the listed park facilities available for
29	rent under special event or exclusive use permits, and are incorporated herein by
30	this reference.

32	Section 3. The above referenced fees and charges will be incorporated into
33	the omnibus fee resolution to be adopted later this year.

35	Section 4. This Resolution is effective as of the date of its adoption.
