3 **A RESOLUTION OF THE CITY OF LINCOLN CITY ORDERING THE TEMPORARY**  
4 **CLOSURE OF SW 29<sup>th</sup> STREET, NE 36<sup>th</sup> DRIVE AND NE WEST DEVIL'S LAKE ROAD**  
5 **DURING CONSTRUCTION OF THE SW 29<sup>th</sup> STREET AND NE 36<sup>th</sup> DRIVE**  
6 **IMPROVEMENT PROJECT**

7  
8 **RECITALS**

9  
10 Pursuant to LCMC 10.08.010, the City Council may exercise Traffic Control authority  
11 by Resolution of the Council; and

12  
13 The Temporary blocking or closing of street is expressly listed as within the authority  
14 of the City Council; and

15  
16 The contract for construction of the SW 29<sup>th</sup> Street and NE 36<sup>th</sup> Drive Improvement  
17 Project requires the closure of SW 29<sup>th</sup> Street during construction; and

18  
19 City Council or City Manager approval of the road closure is required; and

20  
21 The City Council finds and determines that there is a public benefit in temporary  
22 closure to facilitate the above-referenced public improvement project.

24 **NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF**  
25 **LINCOLN CITY, AS FOLLOWS:**

26 **SECTION 1. RECITALS.** The above recitals are true and correct and are  
27 incorporated herein by this reference.

28  
29 **SECTION 2. IMPOSING TRAFFIC CONTROL.**

30  
31 Effective upon issuance of a notice to proceed from the City Engineer, or  
32 designee, authorizing the above-referenced work, the requested construction  
33 road closure is hereby approved as follows:

35 • From May 2021 through September 3, 2021, SW 29<sup>th</sup> Street from Hwy 101 to  
36 SW Coast Avenue will be closed to through traffic for constructing a sidewalk,  
37 on-street parking and an asphalt overlay. Residents will be notified and the  
38 Contractor will coordinate access. The exact dates of closure will be

1 determined when the Contractor develops a schedule. Updates about the  
2 project and closure will be posted on the City's website under Public Works.

- 4 • From May 2021 through September 3, 2021, NE 36<sup>th</sup> Drive from 200 feet east  
5 of NE Surf Drive to NE West Devils Lake Road will be closed for an asphalt  
6 overlay project. The closure time will be up to 6 hours and residents will be  
7 notified of the exact schedule once determined.
  - 8
  - 9 • From May 2021 through September 3, 2021, NE West Devils Lake Road from  
10 NE 35<sup>th</sup> Drive to Hwy 101 will be closed for an asphalt overlay project. The  
11 closure time will be up to 6 hours. Residents will be notified of the exact  
12 schedule once determined. A reader board will be used to notify the public of  
13 the closure in advance.




