21	closure to facilitate the above-referenced public improvement project.

35	14 th Street from Hwy 101 to NE Port Avenue will be closed for construction of a
36	sidewalk and stormwater system. Detours will be in place. Traffic will be routed
37	to the signal at NE 17 th Street for access to Hwy 101.
