4 **A RESOLUTION OF THE CITY OF LINCOLN CITY,**
5 **CALLING FOR A SPECIAL ELECTION TO FILL THE VACANT COUNCIL WARD 1**
6 **POSITION ON THE CITY COUNCIL FOR THE CITY OF LINCOLN CITY**

7
8 **RECITALS**

9
10 **WHEREAS**, on April 12, 2021 Councilor Diana Hinton resigned her City Council
11 position as Councilor Ward 1 of Lincoln City during the regular meeting; Council
12 accepted her resignation; and

13
14 **WHEREAS**, Chapter VIII, Section 8.2, of the Lincoln City Charter, provides:

15
16 **8.2 Filling Vacancies**

17
18 A vacancy in the council shall be filled by appointment by majority of the
19 council, provided, however, that the council may in its discretion call a special
20 election for the purpose of filling such vacancy. The appointee's term shall
21 begin immediately upon his or her appointment and qualification and shall
22 continue through the unexpired term of the appointee's predecessor. During
23 the temporary disability of a council member, or during a member's absence
24 from the city, the office may be filled pro-tem in the manner provided for
25 filling vacancies in office.

26
27 **WHEREAS**, at a special meeting of the City Council on June 14, 2021, pursuant to
28 Chapter VIII, Section, 8.2, of the Lincoln City Charter, the City Council deliberated on
29 the question of whether to appoint a qualified elector to fill the vacancy or refer such
30 vacancy to a Special Election to be held in September 2021; and

31
32 **WHEREAS**, after due deliberation Council by 4-2 vote elected to call for a special
33 election on September 21, 2021 to fill the vacancy; and

34
35 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF**
36 **LINCOLN CITY, AS FOLLOWS:**

38 **SECTION 1.** The above recitals set forth above are true and correct and are
39 incorporated herein by this reference.

1 **SECTION 2.** The City Council hereby declares a vacancy to exist on the City
2 Council, specifically, the position of Councilor Ward 1, owing to the
3 resignation of Councilor Diana Hinton; and


5 **SECTION 3.** The City Council hereby calls for a special election to fill the
6 vacancy on the city council position of Councilor Ward 1, and directs the City
7 Recorder to notify the County Elections Officer and provide notice as set forth
8 in Lincoln City Municipal Code, Chapter 1.12 of the applicable deadline for
9 candidate filing for the September 21, 2021 election.

11 **SECTION 4.** This resolution is effective as of the date of its adoption and signature
12 by the Mayor.


