9	Demonstrate LCNAC 10.00.010 the City Council passed Baselution 2021, 24 which
10	Pursuant to LCMC 10.08.010, the City Council passed Resolution 2021-34 which
11 12	concerns an exercise of Traffic and Parking Control authority in temporarily closing portions of NW 15 th Street and NW 34 th Court; and
13	portions of NVV 13 Street and NVV 34 Court, and
14	The street closures effectively preclude vehicular access to the beach; and
15	The street closures effectively preclude verticular access to the beach, and
16	The Council desires to amend Resolution 2021-34 to extend the duration of the
17	closure of NW 34 th Court; further, although the closure of NW 15 th will lapse on
18	September 6, 2021, the Council will revisit the matter on September 27, 2021; and
19	NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF
20	LINCOLN CITY, AS FOLLOWS:
21	SECTION 1. RECITALS
22	
23	The above recitals are true and correct and are incorporated herein by this
24	reference.

26	SECTION 2. AUTHORITY TO GRANT LIMITED EXCEPTIONS.
27	The temporary closure of NW 34 th Court as directed in Resolution 2021-34 is hereby
28	extended to December 31, 2021. The Interim City Manager is directed to track
29	complaints regarding beach access via NW 15th Street and report to Council on
30	September 27, 2021. The issue of further closure of NW 15 th will be addressed at
31	that time.
32	SECTION 3. NO OTHER CHANGES TO RESOLUTION 2021-34.
33	
34	Except for the authorized extension noted herein, and the amendment previously
35	approved in Resolution 2021-37, Resolution 2021-34 remains in full force and effect.
36	Failure to observe the closure authorized by Resolution 2021-34 is a Class B violation
37	and may be cited under Lincoln City Municipal Code Chapter 1.16.

1	SECTION 4. EFFECTIVE DATE. This Resolution is effective as of the date of its
2	adoption.
