**A RESOLUTION OF THE CITY OF LINCOLN CITY ADOPTING REVISIONS TO THE
CITY ADMINISTRATION (ADMINISTRATIVE FEES – BUSINESS RELATED) FEE
SCHEDULE**

WHEREAS, the City of Lincoln City has established fees and charges for various applications; and

WHEREAS, on March 14, 2022 the City of Lincoln City passed Resolution 2022-07 which included moving several fees from Planning and Community Development to City Administration; and

WHEREAS, ORS 294.160 mandates that the City provide an opportunity for public comment when fees or charges are established or increased; and

WHEREAS, none of the City Administration Fees moved from Planning and Community Development are being increased at this time; and

WHEREAS, Council desires to approve the placement of fees under City Administration as set forth herein; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF LINCOLN CITY, AS FOLLOWS:**

Section 1. The recitals set forth above are true and correct and incorporated herein by this reference.

Section 2. The schedule of fees and charges are hereby adopted as the current fees and charges for the City of Lincoln City, the above-referenced fees and charges being incorporated herein by this reference.

Section 3. The above referenced fees and charges will be incorporated into the omnibus fee resolution to be adopted later this year.

Section 4. This Resolution is effective as of the date of its adoption.


