
BASIS OF BEARINGS

THE BASIS OF BEARINGS IS THE EAST LINE OF TAX LOT 101 AS SHOWN ON COUNTY SURVEY NUMBER 15351.

BOUNDARY DETERMINATION

THE RIGHT OF WAY OF HIGHWAY 101 AND HIGH SCHOOL DRIVE WERE DETERMINED USING FOUND MONUMENTS AND THE COORDINATES GIVEN ON COUNTY SURVEY NUMBER 18251. THE NORTH LINE OF THE PROPERTY WAS DETERMINED BY HOLDING THE FOUND MONUMENTS ALONG THE NORTH LINE. THE EAST LINE WAS FOUND BY HOLDING THE FOUND MONUMENT AT THE SOUTHEAST CORNER OF THE PROPERTY AND HOLDING THE RECORD DISTANCE FROM THE FOUND 1/2" IRON PIPE ALONG THE NORTH LINE. HOLDING THIS RECORD DISTANCE, THE RECORD INTERIOR ANGLE AT THE NORTHEAST CORNER FIT VERY WELL.
