4 **A RESOLUTION OF THE CITY OF LINCOLN CITY,**
5 **CALLING FOR A SPECIAL ELECTION ON NOVEMBER 7, 2023**
6 **TO FILL THE VACANT COUNCIL WARD 2 POSITION ON THE**
7 **CITY COUNCIL FOR THE CITY OF LINCOLN CITY**

9 **RECITALS**
10

11 **WHEREAS**, on May 22, 2023, Councilor Sydney Kasner resigned her City Council position,
12 effective in July 2023 as Councilor Ward 2 of Lincoln City during the regular meeting; and
13

14 **WHEREAS**, Chapter VIII, Section 8.2, of the Lincoln City Charter, provides:
15

16 **8.2 Filling Vacancies**
17

18 A vacancy in the council shall be filled by appointment by majority of the council,
19 provided, however, that the council may in its discretion call a special election for the
20 purpose of filling such vacancy. The appointee's term shall begin immediately upon
21 his or her appointment and qualification and shall continue through the unexpired
22 term of the appointee's predecessor. During the temporary disability of a council
23 member, or during a member's absence from the city, the office may be filled pro-tem
24 in the manner provided for filling vacancies in office.
25

26 **WHEREAS**, at a regular meeting of the City Council on May 22, 2023, pursuant to Chapter
27 VIII, Section, 8.2, of the Lincoln City Charter, the City Council by unanimous consent decided
28 to refer such vacancy to a Special Election to be held in November 2023 and directed staff to
29 prepare such resolution; and

31 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LINCOLN**
32 **CITY, AS FOLLOWS:**

34 **SECTION 1.** The above recitals set forth above are true and correct and are
35 incorporated herein by this reference.
36

37 **SECTION 2.** The City Council hereby declares a vacancy to exist on the City Council,
38 specifically, the position of Councilor Ward 2, owing to the resignation of Councilor
39 Sydney Kasner; and

41 **SECTION 3.** The City Council hereby calls for a special election to fill the vacancy on
42 the city council position of Councilor Ward 2, and directs the City Recorder to notify
43 the County Elections Officer and provide notice as set forth in Lincoln City Municipal

1 Code, Chapter 1.12 of the applicable deadline for candidate filing for the November
2 7, 2023 election.

4 **SECTION 4.** This resolution is effective as of the date of its adoption and signature by the
5 Mayor.


