Process for Review

Review of commemorative items application is by the Lincoln City Parks & Recreation Director.

Lincoln City Parks & Recreation on the behalf of City of Lincoln City offer pavers and plaques in Schooner Creek Discovery Park. Although donors propose the wording they would like to have placed on the paver or plaque, it does become the property of the City of Lincoln City. Inscriptions on the pavers and plaques are intended to be a positive acknowledgement of a person(s) or event(s). Inscriptions shall typically include the name(s) of the honoree(s) and may include a brief message of tribute or remembrance. Inscriptions may include the name of an organization, business or commercial enterprise when a business is being recognized for a donation or service to the community. The inscription may not include a slogan, logo, or wording that would be considered by the average person to be advertising. As the manager of the paver and bench program, the City of Lincoln City reserves the right to reject any submitted wording which in its opinion fails to meets acceptable community standards and the purpose and family based philosophy of the City of Lincoln City. In all instances, inscriptions may not include profanity, vulgarity, or personal attacks nor reference race, religion, color, deity, ethnic heritage, sexual orientation, disability status, or political views or affiliations. Over time engraved pavers may become damaged, broken, worn out or removed by the discretion of the City of Lincoln City. In these instances, the City of Lincoln City is not responsible to replace or repair any damaged, broken, or removed pavers. The duration of a bench with plaque is 10 years with 1st opportunity to re-apply for the bench.

Installation of the Commemorative Item

Pavers and benches with plaques for Schooner Creek Discovery Park will be all installed during phase 3 of the park construction process, dates TBD.

Donor(s) will be notified when the paver(s) and/or bench(es) are installed.
