

**ORDER EXTENDING THE CITY OF LINCOLN CITY EMERGENCY DECLARATION
SET FORTH IN RESOLUTION NO. 2020-06 TO JUNE 28, 2021**

RECITALS

At its special City Council meeting on March 16, 2020, the City Council approved Resolution 2020-06 declaring an Emergency as a result of the COVID -19 Pandemic.

Resolution 2020-06, Section 2. Paragraph F declares an emergency through April 8, 2020 but provides for extension of the emergency by the City Manager as follows:

F. An estimate of the length of time during which the designated area will remain under the emergency declaration; and

Through April 8, 2020, but may be extended by the City Manager without further Order of the Council for two week increments each extension or for increments consistent with State of Oregon emergency declarations.

By Order, under the above cited authority in Resolution 2020-06, the City Manager extended the duration of the COVID-19 emergency to April 28, 2020; and

On March 23, 2020, the City Manager for the City of Lincoln City concurred with Lincoln County Order 3-23-85 prohibiting short term rentals and lodging, among other things, and the City Council, by unanimous vote, on March 23, 2020 ratified the Manager’s concurrence; and

On April 27, 2020, the City Council by approval of Resolution 2020-11, extended the Declaration of Emergency to May 31, 2020, ratifying therein all City Manager Orders, announcements and imposed restrictions as set forth in various press releases; and

The State of Oregon declaration of emergency has been extended by the governor several times, to July 6, 2020, September 4, 2020, November 3, 2020, January 2, 2021, and May 2, 2021; and

Subsequently, by written Order, under the above cited authority in Resolution 2020-06, the City Manager extended the duration of the City COVID-19 emergency several times, to July 6, 2020, September 4, 2020, November 3, 2020, January 2, 2021, March 3, 2021 and to May 2, 2021 respectively; and

1 The State of Oregon declaration of emergency has again been extended by the
2 governor, in this instance to June 28, 2021; and

4 **NOW, THEREFORE, PURSUANT TO THE AUTHORITY GRANTED IN LINCOLN CITY**
5 **MUNICIPAL CODE, CHAPTER 2.72 AND RESOLUTION 2020-06, THE CITY**
6 **MANAGER OF THE CITY OF LINCOLN CITY DOES HEREBY ORDER AS FOLLOWS:**

8 **SECTION 1. RECITALS.** The above recitals are true and correct and are
9 incorporated herein by this reference.

11 **SECTION 2. EXTENSION OF EMERGENCY DECLARATION.** The duration of
12 the City of Lincoln City emergency declaration in Resolution 2020-06 and Resolution
13 2020-11 is hereby amended and extended from May 2, 2021 to and through June 28,
14 2021, consistent with State of Oregon emergency declarations.

16 **SECTION 3. AMENDMENT.** All other provisions of the Emergency Declaration not
17 specifically amended herein remain in full force and effect.

18 **SECTION 4. EFFECTIVE DATE.** This Order is effective immediately upon its
19 signature by the City Manager.
