2	A RESOLUTION DECLARING AN EMERGENCY AND EXEMPTING THE MARYLAND PUMP STATION REPLACEMENT PROJECT
3	FROM FORMAL COMPETITIVE BIDDING REQUIREMENTS PURSUANT TO OAR 137-049-0150 AND LCMC 2.05.080.A.
4	
5	WHEREAS, on June 23, 2014, following formal competitive bidding, the City
6	Council approved the Notice of Intent to Award the Maryland Pump Station
7	Replacement Project to Dave Roberts Contracting, Inc.; and
8	WHEREAS, the city suspended work on the contract on October 20, 2014 due to
9	changed circumstances at the site; and
10	WHEREAS, on November 12, 2014 the City and Contractor agreed to terminate
11	the contract; and
12	WHEREAS, the delay in the Maryland Pump Station Replacement Project has
13	created a risk of substantial loss, damage, unnecessary or undesirable interruption or
14	degradation of public facilities or services, and public health threat requiring prompt
15	award and execution of a contract to remedy the situation; and
16	WHEREAS, under the City's public contracting code, which implements State
17	contracting requirements, the City Council may declare an emergency and enter into a
18	public contract without first obtaining competitive bids or proposals; and
19	WHEREAS, pursuant to LCMC 2.05.080.A(2), the City Manager, through the
20	Public Works Director, has filed the prerequisite written report with the Council
21	describing the proposed contract and explaining the circumstances that create the
22	emergency, said report incorporated herein by this reference; and
23	WHEREAS, the circumstances creating the emergency include the continued
24	degradation of the Pump Station facility, including the necessity of frequent
25	maintenance to keep the facility operational and avoid improper sewage discharges;
26	and
27	WHEREAS, the time constraints associated with the emergency work make

- formal competitive bidding processes impossible and necessitates an emergency procurement;
- NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LINCOLN CITY, AS FOLLOWS:
- Section 1. The Council finds that the facts as stated in the recitals to this
  Resolution and the Report of the City Manager/ Public Works Director, are true and
  correct and support this Resolution and are incorporated herein by this reference; and
  Section 2. The Council finds that an emergency as defined in OAR 137-049-0150
  and LCMC 2.05.080.A exists in that there is a substantial risk of loss, damage, or
  unnecessary or undesirable disruption or interruption of public facilities and services, or
  a threat to health and safety (sewage discharge or backup), which loss may be avoided

by an emergency procurement of construction services; and

- Section 3. The Council authorizes the City Manager to directly award such emergency contract to a contractor experienced with pump station replacement and directs the Manager to utilize the prior formal competitive bidding for this project by soliciting the second lowest bidder first, followed by the third bidder until a qualified contractor is found and if not found to seek competitive quotes; the Manager need not solicit written or oral requests for offers if the Manager determines a direct award to a qualified bidder under the prior formal procurement is possible within ten days of approval of this Resolution.
- Section 4. The scope of this Contract must be limited to Work that is necessary and appropriate to remedy the conditions creating the Emergency; the Council authorizes the expenditure of funds up to the \$237. 173.08 (includes \$20,000 contingency). The award of this emergency contract shall occur within 10 days of this Resolution, unless an extension is awarded by the City Manager, but in no case more than fifty days; performance and payment bonds may not be waived by the Manager.
- 27 Section 5. The Council further finds that the emergency contract specifically

1	authorized by this Resolution will result in substantial cost savings to the City, given the
2	familiarity of prior bidders with the contract and that the proposed method of
3	proceeding, utilizing first the prior formal process, will not encourage favoritism in the
4	awarding of the contract or substantially diminish competition.
5	Section 6. This resolution shall be effective as of the date of its adoption by the
6	City Council.
