7	WHEREAS, on January 26, 2015, City Council approved Resolution 2015-02 declaring
8	an intent to establish a local improvement district in the area of NE Voyage, NE Lake
9	Drive & Ne 15 th Street.
10	
11	WHEREAS, the LID will construct a low pressure sewer system within the City's right-
12	of-way and extend a service lateral to each existing property.
13	
14	WHEREAS, each property owner will be required to purchase and install an E-One
15	Grinder Pump System when they connect to the City's system, extend the lateral to the
16	home and decommission their existing septic system.
17	
18	WHEREAS, the City would like to offer financing for these on-site improvements.
19	
20	WHEREAS, the Department of Environmental Quality has a Community Assistance
21	Program that the City could borrow funds for these improvements and re-loan these
22	funds to the property owners.
23 24	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF
25	LINCOLN CITY, AS FOLLOWS:

27	Section 1. Recitals. The recitals set forth above are true and correct and incorporated
28	herein by this reference.

30	Section 2. Delegation. The City Manager, the Financial Planner, the Finance Director
31	and such other persons designated by the City Manager (a "City Official") are each
32	authorized, on behalf of the City and without further action by the Council, to:

34	(1) Make application to DEQ for a Community Assistance Loan; and

1	(2) To execute the necessary documents that may be reasonably required for the
2	consummation and closing of the loan, and any amendments required thereafter
3	and
4	
5	(3) To establish a loan reserve account as may be required.
6	
7	Section 3. Effective Date . This resolution shall take effect on the date of its adoption.
