

1 **RESOLUTION 2015-21**

2 **A RESOLUTION REPLACING RESOLUTION 2014-14 AND RECOGNIZING THE ROADS**
3 **END IMPROVEMENT ASSOCIATION AS A NEIGHBORHOOD ASSOCIATION**
4 **PURSUANT TO THE LINCOLN CITY CITIZENS INVOLVEMENT PROGRAM**

5 WHEREAS, the Mayor and City Council of the City of Lincoln City, along with its
6 staff and citizens, recognize the importance of developing and maintaining healthy
7 neighborhoods throughout the city and the adjacent urban growth area; and

8 WHEREAS, the City of Lincoln City has adopted a policy in its Comprehensive Plan
9 to encourage a variety of citizen programs such as neighborhood associations and other
10 committees to serve in the interest of the community; and

11 WHEREAS, the City of Lincoln City has adopted a Citizen Involvement Program
12 that describes well-organized neighborhood associations as the backbone of any
13 successful citizen involvement program and encourages their formation throughout the
14 city and the urban growth boundary; and

15 WHEREAS, the Roads End Improvement Association has submitted an application
16 for recognition as a neighborhood association that substantially meets the criteria for
17 such recognition;

18 WHEREAS, on August 11, 2014, the City Council approved Resolution 2014-20,
19 which recognized the Roads End Improvement Association as a neighborhood
20 association, with the proviso that within a year of Resolution 2014-20's passage the
21 Roads End Improvement Association amend its Bylaws to include a means for
22 designating spokespeople, means to maintain a current address, and a means for
23 resolving grievances;

24 WHEREAS, on July 13, 2015, the City Council were advised that the Roads End
25 Improvement Association had amended its Policies and Procedures manual to address
26 Council's concerns;

27 WHEREAS, amending the Policies and Procedures manual rather than the Bylaws
28 is satisfactory to Council; and

29 WHEREAS, the Council finds the necessary amendments have been made in a
30 timely manner;

1 NOW, THEREFORE, BE IT RESOLVED by the City Council of Lincoln City that the
2 City Council replaces Resolution 2014-14 with this Resolution 2015-21, and the City
3 Council recognizes the Roads End Improvement Association as a neighborhood
4 association, as that term is used in the Lincoln City Citizen Involvement Program, for the
5 neighborhood shown on the map attached hereto as Exhibit A.


6 This resolution shall be effective upon its passage.

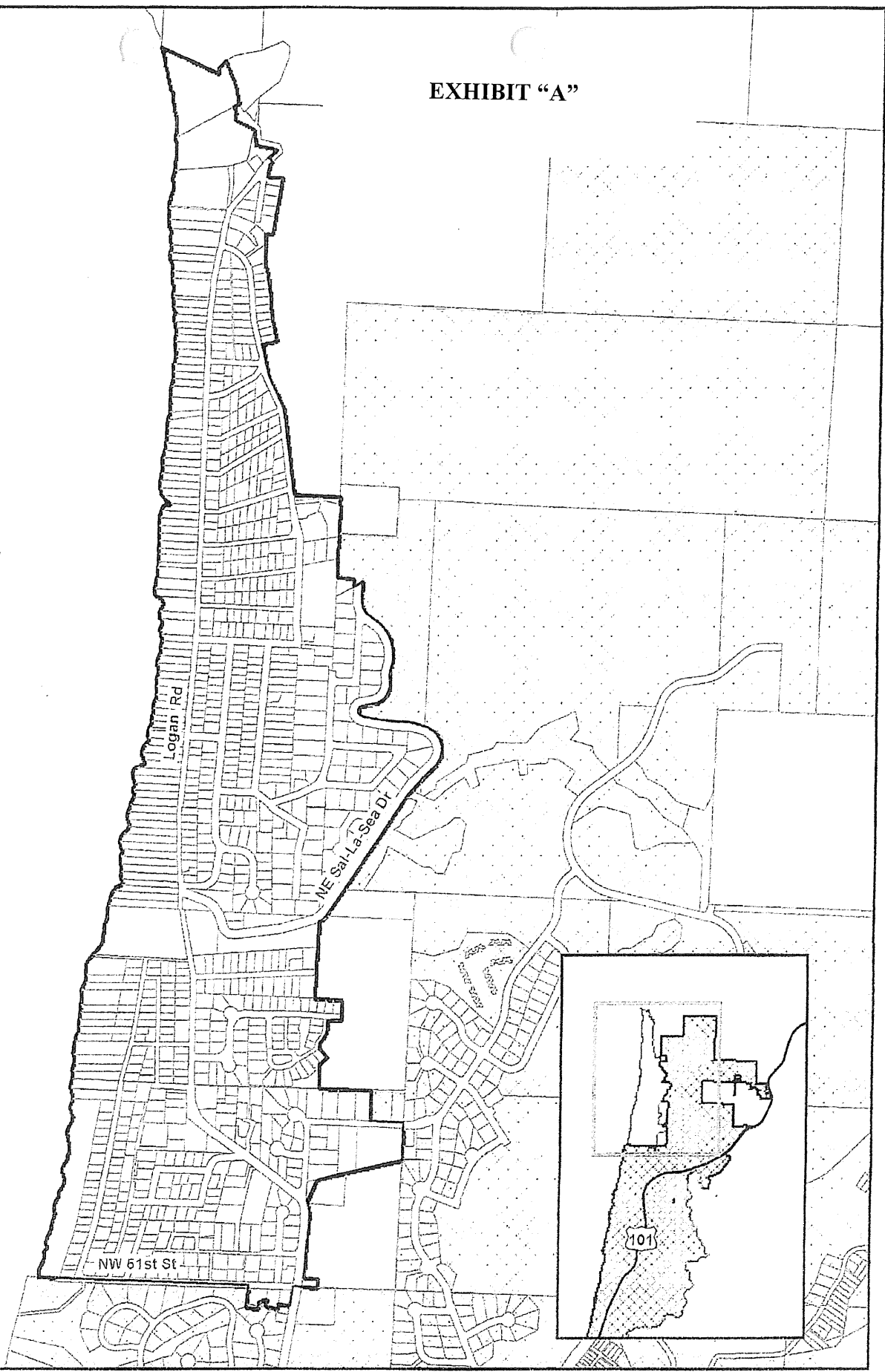
