**A RESOLUTION ADOPTING THE CITY OF LINCOLN CITY'S REPRESENTATION IN THE
LINCOLN COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN**

WHEREAS, the City Council of the City of Lincoln City recognizes the importance of reducing or eliminating those vulnerabilities for the overall good and welfare of the community; and

WHEREAS, the City of Lincoln City has participated in the development of the Lincoln County Multi-Jurisdictional Natural Hazard Mitigation Plan, which has established a comprehensive, coordinated planning process to eliminate or minimize these vulnerabilities; and

WHEREAS, the City of Lincoln City's representatives and staff have identified natural hazard risks and prioritized a number of proposed actions and programs needed to mitigate the vulnerabilities of the City of Lincoln City to the impacts of future disasters; and

WHEREAS, these proposed projects and programs have been incorporated into the Lincoln County Multi-Jurisdictional Natural Hazard Mitigation Plan that has been prepared and promulgated for consideration and implementation by the cities of Lincoln County;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Lincoln City, as follows:

Section 1. The City Council of the City of Lincoln City hereby accepts and approves of its section of the Lincoln County Multi-Jurisdictional Natural Hazard Mitigation Plan as a reasonable process to identify and plan for potential hazards in the City of Lincoln City and Lincoln County,

Section 2. The agency personnel of the City of Lincoln City are requested and instructed to pursue available funding opportunities for implementation of the actions and proposals designated therein,

Section 3. The City of Lincoln City will, upon receipt of such funding or other necessary resources, seek to implement the mitigation proposals identified by the Jurisdiction's Hazard Mitigation Planning Committee, and


Section 4. The City of Lincoln City will continue to participate in the updating and expansion of the Lincoln County Multi-Jurisdiction Hazard Mitigation Plan in the years ahead, and

Section 5. The City of Lincoln City will further seek to encourage the businesses, industries and community groups operating within and/or for the benefit of the City of Lincoln City to also participate in the updating and expansion of the Lincoln County Multi-Jurisdiction Hazard Mitigation Plan in the years ahead.
