8	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF

10	Section 1. Effective January 11, 2016, Bank of America, Lincoln City Branch; Wells Fargo	
11	Bank, Lincoln City Branch; Bank of the West, Lincoln City Branch; and the Local Government	
12	Investment Pool are designated depositories of the City of Lincoln City, Oregon. Funds deposited at	
13	such institutions may be withdrawn upon a check, draft, or other order of the City.	
14	Section 2. All checks, drafts, or orders drawn against City accounts may be signed by the	
15	Finance Director, City Manager, Mayor, Council President, and/or the Chief of Police. All signatures	
16	of these persons shall be duly certified to said banks, and/or the Local Government Investment Pool.	
17	No checks, drafts, or other orders drawn against said banks shall be valid until so signed.	
18	Section 3. Said banks, and/or the Local Government Investment Pool are authorized and	
19	directed to honor and pay any checks, drafts, or orders so drawn, whether or not such checks, drafts,	
20	or orders are payable to the order of any such person signing and/or countersigning such checks,	
21	drafts, or other orders, or any of such persons in their individual capacities, and whether or not such	
22	checks, drafts, or orders are deposited to the individual credit of the person so signing and/or	
23	countersigning said checks, drafts or orders of the City.	
24	Section 4. This Resolution shall continue in force and said banks may consider the facts	
25	concerning the holder of said offices, respectively, and their signatures to be and continue as set forth	
26	in the Certificate of the Recorder accompanying a copy of the Resolution when delivered to said	
27	banks, or the Local Government Investment Pool, or in any similar subsequent certificate, until	
28	written notice from City withdrawing such certification is duly served on such bank or banks.	
29	Section 5. This resolution is effective as of January 11 th 2016.
